Item 1. Security and Issuer.

This Amendment No. 5 to Schedule 13D is being filed as an amendment to the initial statement on Schedule 13D relating to the Common Stock, \$0.001 par value per share ("Common Stock") of Akcea Therapeutics, Inc., a Delaware corporation (the "Issuer") as filed with the Securities and Exchange Commission (the "SEC") on July 27, 2017 (the "Original Schedule 13D") as amended by Amendment No. 1 filed April 26, 2018, Amendment No. 2 filed August 7, 2018, Amendment No. 3 filed October 22, 2018 and Amendment No. 4 filed April 2, 2019. The principal executive offices of the Issuer are located at 22 Boston Wharf Road, 9th Floor, Boston, Massachusetts 02210. This Amendment is being filed to report the acquisition of an aggregate of 6,873,344 shares of the Issuer's Common Stock by Ionis Pharmaceuticals, Inc., a Delaware corporation ("Ionis" or the "Reporting Person"), on December 17, 2019.

Items 2(c), 4 and 5 of the Original Schedule 13D are hereby amended and supplemented to the extent hereinafter expressly set forth and, except as amended and supplemented hereby, the Original Schedule 13D remains in full force and effect. All capitalized terms used in this Amendment No. 5 but not defined herein shall have the meanings ascribed thereto in the Original Schedule 13D.

On December 17, 2019, the Reporting Person received 6,873,344 shares of the Issuer's Common Stock in satisfaction of the Issuer's obligations to the Reporting Person pursuant to that certain Development, Commercialization and License Agreement, dated December 18, 2015, between the Issuer and the Reporting Person.

- (c) The Reporting Person has not effected any other transactions in the Issuer's Common Stock within the past sixty days, except as provided herein.
